On water diversion reporting the Delta Alternative Compliance Plan is proceeding satisfactorily.

It was reported that DWR indicated that the Delta Levee Subvention program would be funded for the year ending June 30, 2025 for 14 million dollars.

The SWRCB is proceeding with voluntary agreements to address minimum stream flows

other measures as part of their effort to update Delta water quality objectives.

On the 2015 coordinated curtailment cases the award of attorney fees for CDWA and other plaintiffs is proceeding for payment.

A general discussion took place concerning the SWRCB methodology for determining curtailments of water rights.

Agency litigation is moving forward on multiple issues including the DCP EIR.

Thereafter, there being no further business to come before the meeting the meeting was adjourned.
